

# WORLD HEALTH DAY

World Health Day is celebrated on 7 April to mark the founding of WHO, the World Health Organization. Each year, the Organization selects a key health issue, and encourages people from all ages and all backgrounds to hold events that highlight the significance of this issue for good health and well-being. World Health Day provides a unique opportunity for communities from across the world to come together for one day to promote actions that can improve our health.

On World Health Day 2011, WHO will introduce a six-point policy package to combat the spread of antimicrobial resistance.

Antimicrobial resistance – also known as drug resistance – occurs when microorganisms such as bacteria, viruses, fungi and parasites change in ways that render the



medications used to cure the infections they cause ineffective. When the microorganisms become resistant to most antimicrobials they are often referred to as "superbugs". This is a major concern because a resistant infection may kill, can spread to others, and imposes huge costs to individuals and society.

Antimicrobial resistance is facilitated by the

Antimicrobial resistance is facilitated by the inappropriate use of medicines, for example, when taking substandard doses or not finishing a prescribed course of treatment. Low-quality medicines, wrong prescriptions and poor infection prevention and control also encourage the development and spread of

drug resistance. Lack of government commitment to address these issues, poor surveillance and a diminishing arsenal of tools to diagnose, treat and prevent also hinder the control of drug resistance.


# HOTEL AT THE CORNER OF BITTER AND SWEET IS NEXT SELECTION

Though the story is set at the turn of the 19th century, it retains a fascination for modern readers, continuing near the top of lists of 'most loved books'. It has become one of the most popular novels in English literature, and receives considerable attention from literary scholars. Modern interest in the book has resulted in a number of dramatic adaptations and an abundance of novels and stories imitating Austen's memorable characters or themes. To date, the book has sold some 20 million copies.

nese-Americans during World War II. It explores the age-old conflicts between father and son, the beauty and sadness of what happened to Japanese Americans in the Seattle area during World War II, and the depths and longing of deep-heart love. We have a glimpse of the damage that is caused by war-not the sweeping damage of the battlefield, but the cold, cruel damage to the hearts and humanity of individual people.

# FOUNDATION CONTRIBUTES TO RELIEF EFFORTS IN NEW ZEALAND, JAPAN



The Altrusa International Foundation, Inc. has received numerous emails from Altrusans who have expressed concern about the devastating earthquakes in New Zealand. The Foundation has sent a contribution of \$1000 (US) to the New Zealand Red Cross from its Disaster Relief Fund to assist with the relief efforts underway. At its March 1, 2011 meeting the Board of Trustees addressed an additional contribution to be sent to the New Zealand Red Cross.

The review Committee of the Foundation's Disaster Relief Fund also approved a grant of \$1000 (US) under the Club Disaster Recovery Service Grants be sent to Altrusa International, Inc. of Christchurch in response to their application for funds to assist them with their relief efforts in the community.

Remember that the Foundation is a 501 (c)(3) organization and therefore contributions will be tax deductible. Also keep in mind that individual checks to New Zealand will incur a currency conversion cost and will probably take longer to be received by those who are desperately in need of this assistance.

Altrusa and the International Foundation's concern for the well-being of the world around us prompted the International Foundation to also approve a contribution in the amount of \$500 (US) which was sent to the American Red Cross specifically for the relief efforts being conducted in Japan as a result of the devastation that has followed the recent earthquake and tsunami that struck in that country.


