FINANCE COMMITTEE REPORT

ADMINISTRATIVE BUDGET SURVEY RESULTS ANNOUNCED

The Finance Committee greatly appreciates your participation in the Finance Survey. Over half our members responded. Your input will help us prepare budget recommendations. The following is a brief summary of the results from the administrative portion of the survey:

- 80% of the members surveyed are willing to support administrative fundraisers
- 87% are agreeable to including the program meeting room costs in the operational costs with a \$15 increase in dues and a \$2 decrease in the cost per
- The majority think the club should pay for 50%,

- or less, of the delegates' registration fees for District Conference and International Convention
- The majority (60%+) are not willing to increase dues to cover District Conference and International Convention registration fees for delegates and alternates
- 52% are agreeable to a dues increase in addition the \$15 increase (which will include program meeting room costs as an operational expenses) with a \$2 decrease in dinner costs

ELECTION OF OFFICERS AND DIRECTORS

From 2011-2013 Altrusa International Bylaws and Policies, Revised September 29, 2011 (emphasis added)

Article XIII: Election of Officers and Directors Section 1. Election

(a) All officers, except the Immediate Past President, shall be elected by ballot at a regular business meeting in March and shall be installed so as to take office on June 1, and shall serve for one (1) year or until their successors are elected and installed. In the event there is only one nominee for an office, the Secretary may be instructed to cast the ballot. Officers of a newly organized Club shall serve until the 31st day of May following such organization, except that Officers of Clubs organized after January 1 and before June 1 may serve until one year from the next June 1.

(b) Any candidate who shall receive a majority of all valid votes cast shall be declared elected. In the event there shall be more than two (2) candidates for any one office, and no candidate shall receive the majority of all valid votes cast on the second ballot, the candidate receiving the least number of votes shall be eliminated from each succeeding ballot.

Section 2. Incoming Board of Directors

Officers and Directors may meet at any time after their election, at the call of the incoming President, for the purpose of organization and to ratify committee appointments.



Several weeks later, Hal --now injured--is discharged from the army and goes to Stratford on Avon to fulfill his promise. But


things take an unexpected turn when he meets the woman in the photo and falls in love with her himself. Wow, there were some pretty emotional responses to this book. Some of us were angry and/or disappointed with Hal, some with Sam, and a few with the author for the abrupt ending. At any rate, it was a spirited discussion.

We're really excited about the February selection, the timeless classic *To Kill a Mockingbird*, by Harper Lee. Published in 1960, the book is Lee's her first and only novel and she won a Pulitzer Prize. The book is still

admired, widely-taught, and beloved. The movie, staring Gregory Peck, received several Academy Awards in 1962.

Told through the eyes of Jean Louise "Scout" Finch, you learn about her father, Atticus Finch, an attorney, who plays the role of teacher to Scout, her brother Jem. and his town. Atticus believes that people usually contain aspects of both good and evil, but that good



will usually prevail. Atticus teaches this to his children, but also to the town, as he works to defend Tom Robinson, an innocent black man accused of raping a white woman. In the racist town of Maycomb in the heart of America's South during the Depression era, this is a Herculean task. Despite the challenge of overcoming the town's deeply ingrained racism and forcing people to change their social perspectives, Atticus struggles on, because he believes that one day, goodness will prevail over the evils of racism and racial equality will exist.

We have a fantastic variety of books for your reading pleasure in 2012. We made an effort to include classics, new books, mysteries, non-fiction, and just plain fun reads. If you would like to read ahead, our March selection is Major Pettigrew's Last Stand.


Our own Bonnie Perry will be the


NEW MEMBER MELODY TERRY
