- ☐ In the event there is only one nominee for an office, the Secretary may be instructed to cast the ballot.

In the event there shall be more than two (2) candidates for any one office, and no candidate shall receive the majority of all valid votes cast on the second ballot, the candidate receiving the least number of votes shall be eliminated from each succeeding ballot.
- ☐ The Incoming Board of Directors may meet at any time after their election, at the call of the incoming President, for the purpose of organization and to ratify committee appointments.

MARCH 15 PROGRAM MEETING: DISTRICT VISITOR, OUR BIRTHDAY

Our guest speaker at the February Program Meeting will be Dr. Sarah Samaan, author of *The Smart*

Woman's Guide to Heart Health. A Vanderbilt University Medical School graduate, Dr. Sarah Samaan is a board certified cardiologist who considers heart disease prevention the cornerstone of her medical practice. While she is skilled in caring for patients with heart attacks, heart failure, and other devastating consequences of cardiovascular disease, she works passionately to educate women on the message that heart disease prevention should be a life-long pursuit.

Dr. Samaan's book, *The Smart Wom-an's Guide to Heart Health*, was released in March 2009, and was selected for the Book

of the Year Bronze Award in Women's Issues by Fore-Word Book Reviews. This book is a holistic, medically sound guide to health and vitality, written to help empower women to make smart choices about diet, exercise, and lifestyle. Her next book, *Best practices for a Healthy Heart, a Cardiologist's Seven Point Plan for Preventing and Reversing Heart Disease*, will be released by The Experiment and distributed by Workman in January 2012. This book will extend Dr. Sa-

maan's life affirming message to men, with completely updated heart health information for both genders.

Dr. Samaan is the Co-Director of the Women's Cardiovascular Institute at The Baylor Heart Hospital, located in Plano, Texas in the Dallas-Fort Worth Metroplex. Dr. Samaan practices cardiology at Legacy Heart Center in Plano, Texas, and has been in practice since 1995. Her areas of expertise include echocardiography and nuclear cardiology.

For the past four years, Texas Monthly magazine has named Dr. Samaan as a "Texas Super Doctor." She has been acclaimed as one of "America's Top Physicians," by Consumers' Research Council of America,

and is widely recognized as an expert on cardiovascular

disease in women. Dr. Samaan currently serves as a spokesperson for the American Heart Association.

Away from work, Dr. Samaan's passion is horses. She enjoys dressage and cross country jumping, and stays fit with a regimen of running, Pilates, and yoga.

The International ADICATING POVERTY Relations Committee is

jewelry parties before both March meetings to bring awareness to the United Nations International Women's Day, March 8. In Uganda thousands live in extreme poverty earning less than \$1.25 per day. The Bead for Life organization is dedicated to eradicating poverty by creating opportunities for women to live with pride and dignity. In the northern part of Uganda, women gather shea nuts and press them into shea butter to create income, food, medicine, school fees and hope. In other parts of Uganda, women turn recycled paper into beautiful bead jewelry. Women working with the Bead for Life organization support on an average 7 children each. They are hard working and represent nearly every tribe in Uganda. They live in extreme poverty, many with HIV/AIDS, and many are internally displaced from the 20+ year war in northern Uganda.

It is the Bead for Life goal to have these women in Uganda lift themselves out of poverty by becoming independent and self-sustaining members of society. The women are

trained to roll beads and make jewelry, which is bought twice a month at fair trade prices.

Bead for Life supports entrepreneurial development

by helping participants setup savings accounts and by providing business training and helping to match business funds. They also work with participants to launch successful businesses within the Ugandan economy.

The money raised at Bead for Life jewelry parties helps to raise awareness about the extreme poverty in Uganda and helps to share the inspiring stories of participants. The money raised is invested in community development work that not only fights poverty, but also helps in health care, vocational training, affordable housing, and entrepreneurial skill development. Please plan to arrive early to the March meetings to help connect with people worldwide in a circle of exchange that enriches everyone.


