November Board Meeting Notes







\$1,500 Grant Awarded to Ann Eisemann Inclusive Playground

In October, the Board of Directors voted to recommend, and the Foundation Trustees approved, a grant of \$1,500 be awarded from our special Community Initiative Fund for the Ann Eisemann Inclusive Playground at Cottonwood Park. The playground is named for Ann Eisemann. Ann (a beloved, longtime member of Altrusa) and her husband Chuck Eisemann, have been community leaders for many, many years. The playground project is spearheaded by the Richardson East Rotary Club, in conjunction with Richardson Parks and Recreation Dept., and support from many community organizations and individuals.



As a sponsor of the playground, all Altrusans are encouraged to attend the Groundbreaking Ceremony, if possible. This is another opportunity to make Altrusa more visible to the Richardson Community. Plans for items to be added to Cottonwood Park include:

- Equipment to allow access to children with mobility issues and wheelchairs
- 100 percent coverage of surfaces to accommodate wheel-chair travel
- A fence to control exit points for children
- More shade elements
- A restroom, with changing table, next to the playground
- More handicapped parking spots next to the playground

NO chocolate, chocolate chip cookies, alcohol... anything that would melt in the desert heat.

Altrusa of Richardson's fourth annual Kindness Action Ninja (KAN for short) Weekend is April 5-7, 2019. Our largest project, is *Care Packages for the Military*. The care packages will contain items that are very necessary, often difficult to obtain abroad, and certainly not always thought of by those of us at home.

On April 6, 2019, our members will gather at Friends Place at 9:00 am to fill, seal, address, and mail our goal of two hundred "Care Packages". Notes of encouragement will be included (with deepest thanks for their service) from the Kindness Ninjas of Altrusa Richardson.

A \$1,500 grant from Altrusa International Foundation will help to fund the purchase of items and the cost of mailing. Club members are asked, if they so choose, to collect or donate materials and snacks to augment our lofty goal.

Please see the suggested items below to guide you while shopping. If you can get 50 or 100 (or more) of one item that's terrific, but we do ask that you bring at least 10, if you can. Bring your donation to meetings between January 2nd and April 1st.

| SUGGESTED ITEMS: SNACKS — Salty and Sweet

COOKIES — plain/iced oatmeal, raisin, peanut butter, sugar and molasses, homemade or store bought

CRACKERS — no saltines, but Trisket, Chickn-in-a-basket, Ritz, Wheat Thins, etc.; Chips in cans; cheese crackers

FRUIT SNACK — (Resealable bags) dried banana chips, apple slices, apricots; golden raisins; freeze dried berries; Trader Joe's fruit tapes

NUTS — cans or small individual sleeves of mixed nuts, honey roasted peanuts, almonds, pistachios, macadamias, sunflower or pumpkin seeds

■ DIPS/CONDIMENTS — small cans of bean or cheese dip

MEATS/FISH —Slim Jims or other individual packaged beef (no pork); non-perishable beef jerky or beef sausage; (make sure labled USDA Beef); Quality canned sardines, smoked oysters or clams

BEVERAGES/SOUP — (to mix with water or milk) instant breakfast; Gatorade/sweetened drink mixes, water enhancers (liquid or crystal); instant coffee or cocoa, lemonade, tea bags, creamer; soup in a cup

CEREAL — (small 6 /8 packs) Frosted Flakes, Trix, Cheerios, Nuts & Honey, Honeycomb

ENERGY/PROTEIN BARS — granola bars, small bags of trail mix (no chocolate), snack cakes

ENHANCERS — to mix with MRE's (Meals Ready to Eat), I ramen noodles, seasoned salt, packets of hot sauce, I mustard, relish, ketchup; taco seasoning for meat or I chicken

TOILETRIES — toothbrush, toothpaste, dental floss piks; cotton swabs, shaving lotion, disposable razors, shampoo, small packages tissues; individually packaged baby wipes, eye drops, lip balm, lotion; aspirin and other pain relievers; feminine hygiene products; zinc oxide crème in tubes; moleskin, foot powder

ENTERTAINMENT — paperback books, current magazines, comic books, word games, crossword puzzles, foam footballs and basketballs, frisbees, hacky sacks, playing cards, yo-yos, Sunday comics, coloring books and colored pencils

OTHER HELPFUL ITEMS — large rolls of "gaffers" tape in black green and tan (like duct tape but fabric) *matte finish only* — *not shiny*; Batteries (no lithium) size AA & D are in high demand

WRITING MATERIALS — notepaper, stationary, envelopes, pens pencils and stamps
