

## *FINANCE COMMITTEE*

### Mid-Year Report for Altrusa International of Richardson

Monthly reports for June through Dec. 30<sup>th</sup> 2020 are available and Balanced. The November and December reports are located on the Website.

#### **Budget Review:**

When the Administration Budget was prepared last spring the committee assumed a near breakeven deficit of \$522.00 for the year. **Administrative Budget balance of December 31, 2020      \$2,990.32.**

Due to Covid constraints revenues and expenditures were curtailed due to in-person event cancellations reduced costs and revenues.

Total revenues were lower due to the \$0 balance of Dinner Income, \$ 0 for Other Income (Birthdays, Brags, Fines, Name Badges, Yearbook Sales, Rental Deposit). These lower numbers were offset by slightly higher Membership renewals than assumed, donations, and greater but modest interest income.

Expenses were also lower due to the constraints of the Covid outbreak. International Convention costs have been \$0 vs. \$1000 assumed. Dinner expenses; membership expenses (Holiday, Leadership team & new membership kits); general operating expenses, such as marketing, PR, scrap book, conference photo CD, and membership directories, are \$0 or lower as well. District expenses related to conference functions were not incurred. No Officer Administrative costs have been requested. Expenditures that were funded: Business meeting room deposit of \$510, Website maintenance expenses increased \$100 to support Zoom meetings, and minimal PayPal fees.

**Cash Balance as of December 31, 2020      \$8,598.01**

I wanted to let you know what we found out when the committee went to break down the Christmas lights and decorations in the front of Ability House. I had been told a couple of days ago that the caregivers wanted us to also break down the Christmas tree, inside but when I went to check on this we found out from Landon Cole that Ability House was in a severe "lock down" and even worse, that our sweet Robert is in hospital with Covid -19! At this time no one else has come down with it but I will keep checking on them.

As of January 14, 2021: Due to HIPAA regulations Ability Connection could not confirm status of residents.

I wanted to give you a quick update on Ability House. So everyone in the house has tested positive for COVID, but everyone is doing great! Robert came home from the hospital earlier this week. Will remain in the house for at least another week.

Our Training Center is still shut down probably will stay shut down until February 1<sup>st</sup>.

Also good news is we have access to the vaccine, and many of our members and staff have already received the vaccine.

In other news, we have been cleaning out old files and came across some past pictures of Altrusa at Ability House.

I would like to be able to do this once a month.....not just me but everyone. When I send them out it will be one at a time, IE. Nina get's sent today, two days later Robert's goes out and so forth. It's more fun to stagger them so they don't get all excited for one day and then nothing! But if enough of us are doing this we can keep them entertained for a good long while!
